Health-care wait times in Quebec hit 16.3 weeks

MONTREAL—Quebec’s median wait time for medically necessary treatment this year was 16.3 weeks, a slight increase from last year, finds a new study released today by the Fraser Institute, an independent, non-partisan Canadian public policy think-tank.

Across Canada, the median wait time in 2019 was 20.9 weeks.

“Following significant improvements last year, wait times for medically necessary treatments in Quebec appear to be increasing again,” said Bacchus Barua, associate director of health policy studies at the Fraser Institute and co-author of *Waiting Your Turn: Wait Times for Health Care in Canada, 2019*.

The study examines the total wait time patients face across 12 medical specialties—from referral by a general practitioner (i.e. family doctor) to consultation with a specialist, to when the patient ultimately receives treatment.

It finds that Quebec’s average wait time of 16.3 weeks is longer than the 15.8 weeks physicians reported last year. In 1993, however, Quebec’s wait time was 7.3 weeks when the Fraser Institute first began tracking wait times in Canada.

Patients in Quebec waited the longest for orthopaedic surgery (29.1 weeks) and ophthalmology (21.5 weeks), and the shortest for medical oncology (4.5 weeks).

“Long waits for medical treatment aren’t a trivial matter—they can increase suffering for patients, decrease quality of life, and in the worst cases, lead to disability or death,” said Fraser Institute Senior Fellow Yanick Labrie.
